**Notice inviting Auction of trees.**

Prequalification application with earnest money deposit and open spot auction bids are hereby invited for the public auction on 09.06.2011 at 11 A.M. at Circuit House meeting hall for disposal of 49 Nos. of identified trees sanding at the approach road of New Circuit House within the premises of Circuit House Complex.


**Other Pre-conditions:-**

- A) Plain paper pre-qualification petitions with due EMD to reach the undersigned by 15.00 hours of 7<sup>th</sup> june 2011.  
B) The authority shall straightway debar the bidder who might appears to be bidding absent in terms of rates and with the mala-fide intention of completion only.

**Other Norms:-**

- i) This notice shall form part of terms and condition of tenders and the bidder shall be bound to abide by them.  
ii) The authority may be proclamation of notice fix subsequent date of price bid conference under unavoidable circumstances.  
iii) The authority reserves the right to turn down any application of prequalification without assigning any reason.  
iv) The bidders are requested to inspect the location of the trees before participating in the auction. In this regard no claims will be entertained after auction.  
v) The successful bidders has to deposit the full amount of the bid amount within 7 days from auction duly adjusting the earnest money already deposited failing which the EMD will be forfeited.  
vi) The successful bidders has no enter in loan agreement with the authority upon a non judicial stamp paper of Rs.10/- at his own cost duly depositing total bid amount to carry out the above work. He will not be allowed to cut the trees without payment of full bid amount.  
vii) The successful bidder will be allowed to cut the standing trees and transport the same at his own cost after depositing the total bid amount subject to execution of agreement only.  
viii) The successful bidders has to obtain the necessary permission /license etc. from the competent authority and deposit appropriate taxes sale tax, surcharge on sale tax etc. before felling cutting and transportation and depositing off to the auctioned trees at his own cost for which the authority will not take any responsibility.  
ix) The successful bidder should cut the identified trees only as mentioned and should not cause any damage to the adjacent and will not be allowed to cut and auctioned trees further. The bidders will be responsible for violation of any rules & regulations of Govt. department concerned in this regard.

- x) The successful bidder has to dispose the sold log within 15 days from the date of auction and he will not be allowed to cut / transport the trees after expiry of the given time.
- xi) The successful bidder will be responsible for any damage to private or Government properties & if any damage occurs he has to repair the same at his own cost.
- xii) The successful bidder has to clean the site of all debris deposited during felling of the trees and level the ground to the full satisfaction of the Engineer-in-charge at site.
- xiii) The authority will not be responsible for any loss or theft or damage that may be caused to any of the natural trees as a result of fire / floods or any other risks from the date of auction done.


